EXECUTIVE DIRECTOR REPORT



On July 19th the Lane County Board of Commissioners (BCC) reappointed two Homes for Good Board members and appointed members. five I'm new delighted to report that Char Reavis and Michelle Thurston were reappointed and I want to give a warm welcome to our newly appointed Homes for Good Board Members Chloe Tirabasso, Larissa Ennis, Joe Iboa, Justin Sandoval and Kirk Strohman, Jr. We are still waiting to find the who two out Lane County Commissioners will be who will serve on the Homes for Good Board and this decision is expected to be finalized in the August 2nd Lane County BCC meeting. Our first meeting on July 27th will have only one decision related to an approval needed for capital project а improvement and the of the rest meeting will be focused on orientation and training for the new Board.

The Nel is a 45 unit apartment community that was completed in June on the corner of 11th and Charnelton in downtown Eugene. This apartment community will serve people in our community who are experiencing homelessness. We had been planning for a grand opening on July 25th, however, due to interest in attending from a national Senior Advisor and Regional Administrator from the Department of Housing and Urban Development (HUD), the Executive Director from Oregon Housing and Community Services and local elected officials we have moved this grand opening to August 1st at 10:00am. All Homes for Good Board members will be invited and are encouraged to attend. New residents will start moving in the week of August 1st.

On 6/30 our auditors, Moss Adams, completed our October 1st, 2020 - September 30th, 2021 (ie FY21) single audit, which includes their opinion and our financial statements. 6/30 was the deadline to submit our audit to HUD, which is 9 months after the completion of the fiscal year. With the Moss Adams Team and the Homes for Good Team working on finalizing the audit it was submitted on the last day, which is not ideal. We didn't upload the audit by the deadline to the Federal Financial Clearing Housing, which will slightly expand the testing scope by our auditors for the FY22 audit. We are also required to submit our completed audit to the State of Oregon within 6 months after the end of our FY. Historically we have not made this deadline and we routinely receive extensions from the Oregon Secretary of State Audit Division.



EXECUTIVE DIRECTOR REPORT

IWe will be issuing a Request for Proposals for auditing services early this Fall and our FY22 audit process will start in December of 2022.

As originally reported in the May Executive Director's Report, Homes for Good is growing rapidly as an organization. This growth is the result of requests from national, state, and local jurisdictions to support new programmatic priorities and allocations. fundina In some cases, especially with Lane County, if we had not stepped up, these jurisdictions would not have been successful in distributina funding allocations and achieving policy priorities, developing such for as Permanent Supportive Housing apartment communities. We now need to make sure our organizational systems are calibrated to administer the new programs and funding in an equitable way. In an effort to review and optimize our organizational Request systems, we issued а for Proposals in February and received three proposals. All three proposals were high quality and we have decided to enter into contract with all three consulting teams. The initial step will be to negotiate general professional services contracts with the three teams and then work with these teams to scope and budget the specific organizational development projects that we need support on. A Division of Moss Adams is one team that we will be working with, and their initial focus will be



assessing our Accounting/Finance Department's systems and staffing. Tusk Consultina will be working with our management team to enhance data driven performance initiatives and succession planning. Governance Leadership Solutions initial focus will be supporting the onboarding and team building with our new governance board.

A. Executive Director Report

Jacob Fox discussed the fence rebuild project he participated in for a family that lost their home in the 2020 Holiday Farm wildfire alongside Oregon Housing and Community Services and Matt McRae from Lane County. He informed the Board that the family was able to insure their previous home and receive partial funding for the rebuild of their property with the assistance of Homes for Good's Energy Services Department.

Jacob Fox discussed the completion of construction for Homes for Good's newest permanent supportive housing development, The Nel. He informed the Board that staff training will take place during July and residents will begin to move in at the beginning of August.

Jacob Fox provided an update on the recruitment process for the Homes for Good Board of Commissioners. He informed the Board that the deadline to apply was May 31st, 2022, and 29 completed applications were received and evaluated.

I MOTION

It is moved that Bridgeway Contracting, LLC., be awarded contract #22-C-0026 for the Service Center Security Fence project and that an order to this effect be signed, and an agreement be executed in accordance with bid documents.

II ISSUE

The Homes for Good Service Center, comprised of one building, is the service center for all Homes for Good employees, located at 100 West 13th Avenue in Eugene, Oregon.

The site currently has a temporary construction fence located on the south east portion of the property for securing Agency owned vehicles. A permanent security fence is needed (and for some funding sources required) to ensure that vehicles, and tools inside the vehicles, are secure.

The Agency hired Pivot Architecture to design the project in December 2021. The project was put out for bid on May 3, 2022. The design of the fence limited the number of contractors that are able to complete the project. Four (4) contractors attended the pre-bid meeting. Two (2) from the Eugene area and two (2) from the Portland area. Bids were opened on June 7, 2022. The two (2) Eugene area companies put in a joint bid for the project, with Bridgeway Contracting, LLC. as the General Contractor and Island Fence, Inc. being the sub-contractor. Neither Portland area contractor submitted a bid due to the complexity of the project and the high cost of mobilization.

Work on this project is scheduled to start in late August and be completed by the end of September 2022.



III DISCUSSION

A. <u>Background</u>

A formal bid process with a bid package was issued by the Agency for the required work. One (1) bid was obtained, and one (1) bid was responsive and responsible.

The public bidding process was employed; the lowest bid has no irregularities and is responsive and responsible. The prices are considered competitive and in range of the Agency's independent cost estimate. We recommend the award of the contract to Bridgeway Contracting, LLC.

The total amount of this bid is \$211,316.00. Bridgeway Contracting, LLC. will provide performance and payment bonds for this contract. Since we received this bid we have determined that federal funds are available from the Rent Assistance Division and Energy Services Division and this will require that this project pay the higher of Federal David Bacon wage rates and State of Oregon Bureau of Labor and Industries wage rates. Initial analysis indicates that this will result in a cost increase, however, we anticipate that this increase only impacts one or two specific labor positions so the total project increase will be manageable.

B. <u>Recommendation</u>
